I. The contractor shall supply and delivery duplicating/ copy paper to Property and Supply (P&S) Office located at U.S. Embassy, Seafront Compound, Pasay City, in accordance with the terms and conditions of the contract.

II. Minimum/Maximum Quantities

For each effective year of the contract, the U.S. Government guarantees a minimum order of two hundred fifty (250) reams. The maximum amount ordered under each year of the contract will not exceed the Estimated Quantity indicated under Section I.II, Pricing and Schedule, subsection A, B & C. This reflects the contract maximum for each period of performance.

Orders may be issued orally by the Contracting Officer, but will be confirmed in writing within three (3) business days of the date the order is placed.

III. Delivery Location and Time

C. Any Contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing Contractor personnel at the time deliveries are made. Prior notice of at least three (3) working days will be required for the preparation of access pass. Access to U.S. Government facilities will not be permitted without access clearance.

- D. If delivery will be to U.S. Embassy, the Contractor shall deliver between the hours of 7:30 a.m. to 3:00 p.m., Mondays through Fridays, except Philippine and American holidays.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. §6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.
